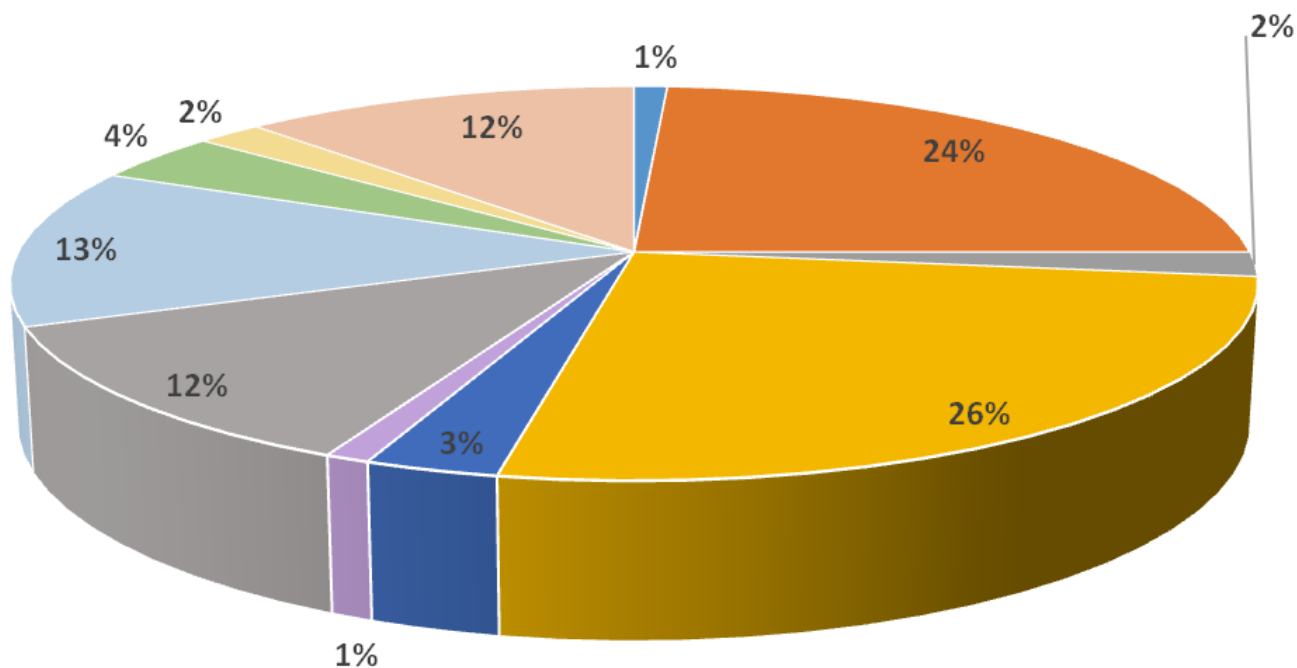

- **cooperation between the Office of the Chamber of Deputies and National Library of Technology since 2011 - 2012**
- **PI papers (analysis) in NUŠL database**
 - 120 PI papers (to 09.10.2015)
 - papers from the period 1992 - 2013
 - future plans: put all available papers to the database
- **84 papers of PI in the NUŠL database (according to the 2013 statistical data)**
